

# Texas A&M University HUB Subcontracting Plan (HSP) Help Guide

First, determine what HSP option will best fit the commodity, project and/or service requirements. Below are the four HSP options.

- Option 1 100% HUB Participation. The respondent will use only HUB subcontractors for the project. (Section 2: c. Yes- Use Method A Attachment)
- Option 2 The respondent WILL MEET/EXCEED the HUB subcontracting goals as identified in the Agency Special Instructions or within the solicitation document. (Section 2: d. Yes – Use Method A Attachment)
- Option 3 The respondent WILL NOT meet the HUB subcontracting goals as identified in the Agency Special Instructions or within the solicitation document. (Section 2: d. No Use Method B Attachment)
- Option 4 Self Perform The respondent will NOT be subcontracting any portion of the contract and will utilize its own resources in completing the project. Provide a narrative on how your company will perform the entire contract with its own equipment, supplies, materials, and/or employees. (Section 2: a. No Fill in Section 3)

# **DETERMINIATION OF GOOD FAITH EFFORT FOR METHOD B:**

- Give proper notification in writing to all potential bidders. A Notification form is included in HSP package you are not required to use this form, but it is highly recommended.
- You must allow the HUBs <u>7 complete business days</u> to respond. The day you send out the notification does not count, bid due date does not count, weekends do not count, and government holidays do not count.
- Notify in writing at least 3 HUB vendors per opportunity. You must provide this documentation with your HSP package when you turn in your bid. HUB vendors can become ineligible at any time so make sure they are an active State of Texas HUB member on the CMBL website:
   <a href="https://mycpa.cpa.state.tx.us/tpasscmblsearch/">https://mycpa.cpa.state.tx.us/tpasscmblsearch/</a>. It does not hurt to send to more than 3 HUB vendors just in case.
- Notify at least 2 trade organizations/development centers of subcontracting opportunities and provide documentation. You must also give them **7 complete business days**.
- Provide written justification of the selection process if a HUB vendor was not selected.

## **POSSIBLE CAUSES FOR REJECTION:**

- Failure to provide 7 complete business days' notice to at least 3 HUB vendors per opportunity AND provide supporting documentation.
- Failure to notify at least 2 trade organizations/development centers AND provide supporting documentation.
- Failure to sign Section 4.
- Failure to turn in a HUB Subcontracting Plan.

# Method A

# Method B

If you are using Method B this means that you WILL NOT meet the HUB subcontracting goals as identified on Page 1 above Section 1, and you must provide documentation of a "good faith effort".

## Section 1:

- Fill in the basic contact information
- Select if your company is a State of Texas certified HUB
- Enter the Requisition #, Bid Number or Project Number then enter Bid Opening Date

## Section 2:

- A. Select YES that you will be subcontracting.
- B. List the subcontracting opportunity description and fill in the percentages
- C. Select No that you will not use 100% HUB Participation.
- <u>D.</u> Select NO that you **WILL NOT meet the HUB subcontracting goals** as identified on Page 1 above Section 1.

## Section 4:

- Sign, Print Name, Title, & Date

Attachment B: You will need to make copies of both of these pages and fill them out for each opportunity listed on Section 2 b.

#### Section B-3:

- List 3 companies you submitted the bid opportunities to and include their Vendor ID, Date Sent, and if they responded.
  - You will need to include backup documentation for all notifications sent to HUB vendors. (i.e. an email sent to vendors) Documentation will need to show date sent, email address and date you requested solicitation back.
  - o You must allow the HUBs <u>7 complete business days</u> to respond. The day you send out the notification does not count, bid due date does not count, weekends do not count, and government holidays do not count.
  - o It is also a good idea to notify more than just 3 HUB subcontractors. HUB vendors may become inactive at any time. If, for whatever reason, they are not HUB at the time you sent out the notification we will be unable to count them as a HUB vendor this may lead to a rejection of bid if you have not notified any other HUB vendors for that opportunity.
- List two trade organizations/development centers you sent the solicitation to and include backup documentation of your solicitation. Documentation will need to show date sent, email address and date you requested solicitation back.
  - O You may only want to notify 2 trade organizations/development centers for every opportunity or notify different trade organizations/development centers for each opportunity. This is your choice, but you must notify at least 2 trade organizations/development centers.
  - You must allow the trade organizations/development centers <u>7 complete business</u> <u>days</u> to respond. The day you send out the notification does not count, bid due date does not count, weekends do not count, and government holidays do not count.

#### Section B-4:

- List the Item Number and opportunity as the Description
- List the selected vendor(s) (enter Full Name) for that opportunity, and include if they are HUB, Vendor ID, Approximate Dollar Amount, and Percentage of Contract
  - Make sure to enter the Vendor ID. Sometimes we come across vendors that have been selected that are actually HUB when we look up the Vendor ID.
- If this vendor is not a HUB please explain why you chose not to use a HUB vendor.



# **HUB Subcontracting Opportunity Notification Form**

You may use this form to send out notification of opportunity to HUB vendors. You are not required to use this form and may use whatever form of written documentation you would like, but you must provide documentation of a notification sent to HUB vendors including what HUB vendors were notified.

# **HUB Subcontracting Plan (HSP)**

In accordance with Texas Gov't Code §2161.252, the contracting agency has determined that subcontracting opportunities are probable under this contract. Therefore, all respondents, including State of Texas certified Historically Underutilized Businesses (HUBs) must complete and submit this State of Texas HUB Subcontracting Plan (HSP) with their response to the bid requisition (solicitation).

NOTE: Responses that do not include a completed HSP shall be rejected pursuant to Texas Gov't Code §2161.252(b).

The HUB Program promotes equal business opportunities for economically disadvantaged persons to contract with the State of Texas in accordance with the goals specified in the 2009 State of Texas Disparity Study. The statewide HUB goals defined in 34 Texas Administrative Code (TAC) §20.284 are:

- 11.2 percent for heavy construction other than building contracts,
- 21.1 percent for all building construction, including general contractors and operative builders' contracts,
- 32.9 percent for all special trade construction contracts,
- · 23.7 percent for professional services contracts,
- · 26.0 percent for all other services contracts, and
- 21.1 percent for commodities contracts.
